

DEVELOPMENT PERMIT APPLICATION

FOR PROPOSED DEVELOPMENT ON LANDS LOCATED IN FLOODPLAIN AREAS

INSTRUCTIONS

TO COMPLY WITH FLOODPLAIN MANAGEMENT REGULATIONS AND TO MINIMIZE POTENTIAL FLOOD DAMAGE, IF YOU ARE BUILDING WITHIN AN IDENTIFIED FLOOD HAZARD AREA, YOU MUST AGREE TO CONSTRUCT YOUR PROPOSED DEVELOPMENT IN ACCORDANCE WITH THE FOLLOWING SPECIAL PROVISIONS:

SPECIAL FLOODPLAIN PROVISIONS:

1. For RESIDENTIAL structures, the lowest floor (including basement) must be elevated one foot above the base flood elevation (100 – year flood elevation) as delineated in the Rogers County, Oklahoma Flood Damage Prevention Ordinance.
2. For NON-RESIDENTIAL structures, the lowest floor must be elevated to or above the base flood elevation, or floodproofed to withstand the flood depths, pressures, velocities, impact and uplift forces associated with the 100-year flood as delineated in Rogers County, Oklahoma Flood Damage Prevention Ordinance.
3. For ALL STRUCTURES, the foundation and the materials used must be constructed to withstand the pressures, velocities, impact and uplift forces associated with the 100-year flood.
4. All utility supply lines, outlets, switches and equipment must be installed and elevated so as to minimize damage from potential flooding. Water and sewer connections must have automatic back flow devices installed.
5. You must submit certification on the attached forms from REGISTERED ENGINEER, ARCHITECT or LAND SURVEYOR, that the floor elevation and/or floodproofing requirement have been met. Failure to provide the required certification is a violation of this permit.
6. You must comply with all other provisions of the Rogers County, Oklahoma Flood Damage Prevention Ordinance.

AUTHORIZATION

I have read or had explained to me and understand the above special provision for floodplain development. Authorization is hereby granted the permitting authority and their agents or designee, singularly or jointly, to enter upon the above-described property during daylight hours for the purpose of making inspections or for any reason consistent with the issuing authority's floodplain management regulation. I further verify that the above information is true and accurate to the best of my knowledge and belief.
